UNDERTAKING BY PARENTS / LEGAL GUARDIANS

Parents or the Legal Guardians as applicable of the applicant seeking admission / enrolment to any of the pre- sea courses, conducted at the Training Ship Rahaman, are required to give undertakings as per the draft contained in pages 2 to 5 of this document. This undertaking must be executed on Rs. 100/- Non Judicial stamp paper, duly signed by the Parents or the Legal Guardians as applicable, witnessed by two witnesses and Notarized.

The admission / enrolment of the applicant to any of the pre- sea courses, conducted at the Training Ship Rahaman will be granted only upon the Parents or the Legal Guardians, as applicable, of the applicant giving the above mentioned undertakings, failing which the applicant will not be admitted / enrolled to any of the pre- sea courses, conducted at the Training Ship Rahaman.

UNDERTAKING BY PARENTS / LEGAL GUARDIANS

I/We, _____ am/are the father of/mother of/legal guardians of Mr./Ms. _____, date of birth _____ who has been selected to be admitted to the _____ pre-sea course commencing from _____, and to be residing in the Training Ship Rahaman's Nhava Campus for the duration of the course.

I/We fully understand and willingly agree to the fact that my/our son/daughter/ward will be admitted to the above said course only upon agreeing to and to fully comply with following undertakings.

UNDERTAKINGS PART ONE

The Training Ship Rahaman may hereinafter be referred to as the T.S. Rahaman, or the Institute, or Foundation.

I/We do hereby solemnly give the following undertaking, most willingly and without being under any compulsion and/or force and/or duress of any nature whatsoever.

1. My/Our son/daughter/ward/ will be attending the _____ course at the T.S. Rahaman.
2. The above said course is fully residential and my/our son/daughter/ward will be residing on the T.S. Rahaman's Nhava campus. The lodgings, along with boarding, will be as provided by the institution.
3. I/We have fully read and understood the rules, regulations, terms and conditions of the T.S. Rahaman as per the Annex I to this undertaking, here attached consisting of **14** pages. Further, I/We hereby fully agree to and understand that rules and regulation are subject to amendments, additions and changes, as and when times, conditions and circumstances require.
4. I/We have made my/our above named son/daughter/ward fully aware of the said rules and regulations as contained in the Annex I, and that he will fully comply with the same for which I/we will be entirely responsible. Further, I/We fully understand and agree to the fact that this also applies to any amendment, additions and changes as and when applicable.
5. I/We have fully read and understood the schedule of misdemeanours, offences and corresponding punishments, as listed in the Annex II to this undertaking, consisting of **13** pages. Moreover, I/We fully understand and agree to the fact that the contents of the Annex II is not all exhaustive and not limited to the contents of the Annex II to this undertaking, as there could be extraneous circumstances. I/We have made my/our son/daughter/ward fully aware of the Annex II to this undertaking. Further, my/our son/daughter/ward will fully comply with the same for which I/we will be entirely responsible.

Additionally I/We agree and consent to the involvement of the local law and order maintenance agency of the State of Maharashtra, this in the event any offences indulged in by my/our son/daughter/ward is of a serious and/or of criminal nature. Further, during the period of training, if my/our son/daughter/ward has deliberately flouted the Rules and Regulations or Code of Conduct

of the T.S. Rahaman, the Management/Principal of the Institute shall be at liberty to discontinue my/our son/daughter/ward's education/training and ask him/her to leave the T.S. Rahaman at any time.

6. I/We undertake to pay the course/training fees/charges on time and in full or in instalment as per the prescribed fee schedule. I/We agree to pay any additional fee/charges levied by the Institute towards meeting any additional expenses that may be involved. If I/We fail to make the aforesaid payments, the management of the Institute shall be at complete liberty to discontinue my/our son/daughter/ward's training and ask him/her to leave the T.S. Rahaman at any time.
7. I/We agree and consent to the forfeiture of any fees already paid in connection with the training, lodging and boarding for my/our son/daughter/ward in the event that my/our son/daughter/ward's training is discontinued and he/she is asked to leave the T.S. Rahaman at any time for any reason.
8. I/We shall not ask for leave for my/our son/daughter/ward during the course of any term/semester. I/We understand that attendance is very important. I/We will not disturb my/our son/daughter/ward or ask to take him/her from the Institute before the prescribed date of closure for vacation.
9. I/We shall not hold the Institute responsible in any manner whatsoever in the event my/our son/daughter/ward leaves the Institute or hostels without prior permission. I/We will not object to any disciplinary action taken against my/our son/daughter/ward by the Institute in case it becomes necessary to do so.
10. I/We also further undertake, that my/our son/daughter/ward will not commit any breach of code of discipline/conduct. And in event my/our son/daughter/ward is found guilty for violation of code of discipline/conduct, I/We will not object to any such action that the Institute or its management may deem it fit to take against my/our son/daughter/ward. I/We agree/consent to the forfeiture of any fees already paid if my/our son/daughter/ward is dismissed from the T.S. Rahaman for misconduct and or misbehaviour. I/We also agree to pay all dues and losses if any incurred by the Institute owing to any act and or omission of my/our son/daughter/ward.
11. I/We also give an undertaking that the Governing Body/Council, Management, The Principal, Heads of any Education and Training, Teaching or Training Faculty or any other Foundation Staff will not be held responsible in any manner whatsoever, for any accident or injury suffered by my/our son/daughter/ward during the course of his/her education or training at the T.S. Rahaman, or whilst going and or returning from Off-Campus Liberty, or whilst on Off-Campus Liberty.
12. I/We fully agree/consent to any emergency medical treatment including any surgery and or hospitalization which might become necessary and agree to pay in full for the same.
13. I/We, hereby affirm that I will not withhold any information regarding my medical records, including any psychological issues, and will fully disclose all relevant details of my past medical history as required during the admission process.

I/We, understand and acknowledge that if it is determined, either during the admission process or subsequent to my admission to the college, that I/We, have wilfully withheld any information pertaining to my medical or psychological history, I/We, may be subject to disciplinary actions, including expulsion from the institution or other measures deemed appropriate.
14. I/We do hereby agree to be promptly present at the T.S. Rahaman as and when required by the Principal/Management, in any eventuality deemed necessary by the Principal/Management of the T.S. Rahaman.
15. I/We fully understand that the language medium used for imparting education and or training at the T.S. Rahaman is the English Language. In view of this I/We give an undertaking that the

Governing Body/Council, Management, The Principal, Heads of any Education and Training, Teaching or Training Faculty, or any other Foundation staff will not be held responsible in any manner whatsoever, for my/our son/daughter/ward's inherent lack of the basic, sufficient and adequate functional knowledge, understanding and comprehension of the language used for imparting of education and or training at the T.S. Rahaman, i.e. the English Language, which would or could result as a hindrance in the desired progress of my/our son/daughter/ward's education and or training at the T.S. Rahaman.

16. I/We hereby confirm that, I/We have secured admission to this college through fair means and that, I/We have not engaged or collaborated with any agents to facilitate my admission. Furthermore, I/We affirm that, I/We have not provided any monetary or other considerations in exchange for admission to this institution.
17. I/We, as parents/legal Guardians, do hereby affirm, that I/We will not hold the Institution nor its Governing Body/Council, Management, The Principal, Heads of any Education and Training, Teaching or Training Faculty, or any other Foundation staff in any manner responsible for any happenstances and any consequences thereof whilst my/our son/daughter/ward is on Off Campus Liberty, or on leave of absence from the Institution's campus for any reasons whatsoever. And I/We as the parents/legal Guardians will be entirely responsible for the same.
18. I/We understands that Course fees once paid, will not be refunded or transferred to any other course and no communication will be entertained in this regard.

I/We understands that all Pre-Sea students are required to successfully complete a swimming test comprising two laps of the Institute's 25-metre long swimming pool (total distance: 50 metres) without any break and without the use of a life jacket or any other flotation aid during the course. Students who fail to complete the swimming test successfully shall not be eligible for the issuance of the Pre-Sea Certificate
